# 1 Introduction

## 1.1 Purpose

The purpose of this document is to outline the requirements for the provision of safeworking services (CRSW's) on the ARTC Network.

## 1.2 Scope

This document is applicable to externally provided CRSW's providing safeworking services under ARTC's accreditation on the ARTC Network.

## 1.3 Ownership

The General Manager – Safety, Systems, Risk and Assurance is the Document Owner, while the General Manager – Procurement and Supply (Finance) is the endorsing party. The Safety Risk and Assurance Manager will be the initial point of contact for all queries relating to its contents.

## 1.4 Responsibilities

The Category Manager and the Safety Risk and Assurance Manager are responsible for the implementation of this procedure.

Approval of amendments to the requirements, including the Supporting Documents, and application of such, will be the responsibility of the document owner and endorsing parties.

## 2 Introduction

### 2.1 Requirements for Authorisation

Organisations must be authorised by ARTC to provide safeworking services on the ARTC rail network. There are 2 groups of organisations authorised by ARTC to provide safeworking services:

1. SPOs; and
2. Members of ARTC's Safeworking Services Panel.

### 2.2 Exclusions

This document does not apply to:

- an ARTC employee, or CRSW employed by ARTC
- employed or engaged by or on behalf of an accredited RIM or RSO (operating under their own accreditation on the ARTC Network) Note: The accredited RIM or RSO applies their own requirements and assurance processes to ensure the quality and accuracy of safeworking applied. This may include the use of their own panel arrangements for safeworking services
- Contractors engaged to back fill an existing ARTC asset maintenance role may conduct safeworking where the engagement is not primarily for safeworking (e.g. signal electrician) under the management and control of the local ARTC team. The ARTC leader must ensure verification and assurance of safeworking as part of the engagement.

## 3 Safeworking Services Requirements

### 3.1 Authorisation Requirements

Authorised providers are required to have specified items in 3.2 in place prior to authorisation.

Failure to maintain these items can lead to a recommendation of authorisation being revoked by the GM Procurement and supply on recommendation from the Safeworking Assurance Specialist.

### 3.2 Items for Authorisation

1. A documented system that demonstrates CRSWs have been fully trained as required by ARTC and that training has been completed by organisations approved by ARTC;
2. A documented mentoring system in place for all employed CRSWs that:
  - a. Records practical safeworking experience for each CRSW within a three-month period including any planning activities;
  - b. Where appropriate, facilitates the professional development and training of CRSWs and provides a framework in which performance issues can be addressed and monitored; and
  - c. Where necessary verification of competencies for new employees.
3. A documented process to ensure the dissemination of safety critical information to each CRSW for a worksite;

4. Documented processes for event reporting and investigation management and that, in the event of a rail safety incident, supports workers being managed in accordance with PEO-GL-001;
5. A records management system to store safety critical information for each worksite;
6. A documented process to monitor and record the performance of each CRSW;
7. A process for self-auditing compliance to ARTCs requirements for organisations authorised by ARTC to provide safeworking services;
8. A documented Drug and Alcohol Management Plan that in the event of a Drug and Alcohol breach supports the worker being managed in accordance with PEO-GL-001;
9. A documented procedure in place to monitor and track the fatigue of its workers that as a minimum meets the requirements of WHS-PR-423 Fatigue Work Instruction;
10. A documented assurance procedure that ensures CRSW(s) will manage the required worksite protection in accordance with:
  - a. ARTC's Safety Management System; and
  - b. Other site safety documents or information provided by ARTC, including but not limited to the PSMP, the SSMP or Work Pack relevant to the worksite.
11. A documented safety management system.

### 3.3 Reporting Requirements

All organisations are required to provide periodic reports as directed by the Scope of Services and SPO Specification document. These include;

- The number of rail safety incidents and breaches of ARTC Policies, Procedures or Standards;
- The number of notifications received from Regulators (e.g. ONRSR, WorkCover/WorkSafe etc.);
- The number of Drug and Alcohol tests conducted, and non-negative test results received based on testing a minimum of 25% of CRSWs provided for each project;
- The number of safety improvements and/or safety initiatives completed (including details of consultation, communication & implementation);
- The number of assurance activities undertaken and results;
- The number of instances where a CRSW was used with a medium or high profile as determined by using the "Contractor CRSW Scorecard COR-FM-014"; and
- Overall feedback on the performance of the CRSWs engaged during the period.

### 3.4 Changes to Authorisation Requirements

Any changes to the requirements set out in in this document, the Scope of Services and SPO Specifications Document must be made in endorsed by the Category Manager and Safety Risk and Assurance Manager, and DDEG and approved by SELT.
