Seeking First Nations artist to create reflective RAP art

We're seeking an artist to create a unique piece of artwork that reflects our reconciliation journey. The artwork will be the centrepiece of our Reflect Reconciliation Action Plan (RAP) and will appear across all our reconciliation activities and initiatives. The piece will need to reflect our values and carry our message of reconciliation across our entire network, spanning five states and more than fifty First Nations.

As the showpiece we'll reproduce the artwork wherever it will visually connect our people, and the communities in which we operate, with our reconciliation vision for safety and wellbeing.

We welcome your proposal, which will need to be submitted by **5:00pm (AEST) on 15 October 2021**.

1 About ARTC

For 21 years, we've been building Australia's largest rail network. Now more than 8,500km long our railway spans five states – New South Wales, Victoria, Queensland, Western Australia, and South Australia. We're committed to keeping freight moving across Australia and we're passionate about the safety and wellbeing of our people.

Our 1,900 employees live in cities and regional areas, all the way from Toowoomba to Kalgoorlie. We manage the safe transit of more than 440 freight and passenger trains per day – some of the freight trains are up to 1,800m long – which is about 260 shipping containers. We know how important it is to reduce congestion on our roads and highways because it's better for the environment and it improves safety for motorists across the country.

It's our value of No Harm that underpins how we work together and in the communities in which we operate. For us, we have an uncompromising commitment to safety and wellbeing. 3 The Project Details

<p>Working together</p>	<ul style="list-style-type: none"> • We'll organise an initial meeting, face-to-face or over the phone, so that we can talk about the project together and align on all the details to make this a valuable working relationship. • We'll take these agreed ways of working, deliverables and organise an agreement for us both to sign up to. <p>Project outcomes to start the conversation</p>	<ul style="list-style-type: none"> • A piece of original two-dimensional art that we can reproduce across our reconciliation activities, which is at least 594mm x 841mm (A1 portrait size). • Provide the story that explains the artwork and how it connects our vision for reconciliation, with the communities in which we live and work, and ARTCs values that we foster. • We will also reproduce the artwork in various forms, for example branded protective clothing, on our website, in reports, in our workplace, on our Intranet, across social media and within the communities in which we operate.

4 Selection Criteria

All proposals will be evaluated by members of ARTC's Reconciliation Action Committee.

The team will use the following criteria, which is not listed in any order.

Visual appeal	Aesthetically appealing which can be adapted for different uses, such as documents, on screen or hi-vis uniforms.
Interpretation	The concepts convey the artist's style and incorporates our values and our reconciliation vision of safety and wellbeing.
Connection	The proposal has a connection to our people and the communities in which we operate.
Cultural Integrity	The artwork meets cultural protocols, integrity, and appropriation of styles.
Protocols	The artist has the capacity and capability to successfully meet the timeframes and demands of this project, and with third-party advice is willing and able to enter an agreement with us. You can view a copy of the agreement here .

5 The Finer Points

- 5.1 The artist must identify as Aboriginal or Torres Strait Islander.
- 5.2 The artwork will be used across many First Nations, so please outline any special/cultural conditions or restrictions relating to the artwork or its use. If the Artwork includes any traditional cultural expressions (TCEs), the artist must obtain all necessary permissions from the traditional owners of those TCEs.
- 5.3 All designs and concepts must be the authentic and original work of the artist submitting the design and cannot incorporate copyright works of other persons.
- 5.4 We may need to modify the colours and/or use part of the artwork, so that we can use the design on the fabric of our protective clothing and wear in the rail corridor i.e. high-vis work shirts. We also encourage you to consider our brand colours and have attached our style guide and tone of voice guide that will provide more details about who we are and our values. - 5.5 The available budget for the artwork is \$5,000 including GST.
- 5.6 We will be required to enter into an [agreement](#), a copy of this is included as an attachment. We will require an exclusive licence of the copyright in the artwork, but the artist will retain ownership of the copyright.
